

## RENTAL CONDITIONS

- 1) Any rental is nominative and can not be transferred under any circumstances.
- 2) In case of delay for your arrival, please notify us: in the absence of a message Writing or telegraphy of the tenant specifying that he had to defer the date of his arrival, The location or the mobile home become vacant 24 hours after the arrival date Mentioned in the rental contract and the full payment of the services remains required.
- 3) The deposit will be deducted from the amount of the royalties, but not reimbursed by the Camping in case of cancellation less than 30 days before the expected date of arrival. Costs Will not be refunded in any case.
- 4) Location rental:
  - A) The location will be available at 12 noon on the day of arrival and must be vacated for 12 Hours on the day of departure.
  - B) The balance of the stay must be paid in full on the day of arrival.
  - (C) No reduction shall be granted in the case of delayed arrival, departure Anticipated or a change in the number of persons and facilities advertised ( Either for all or part of the intended stay).
- 5) Mobile home rental:
  - (A) These may be occupied from 4 pm on the day of arrival and must be Released for 10 hours on the day of departure.
  - B) The balance of the stay must be paid in full 30 days before the date of arrival (under Cancellation of this rental). No reduction shall be granted in the case of Delayed arrival or early departure.
  - C) Mobile homes are rented for a specified number of people. Any excess will be Charged according to the tariff of the "person" benefit in force at the campsite.
  - D) The mobile home will be returned in the same state of cleanliness as on delivery. Otherwise, Tenant will have to pay a lump sum of **100 €** for cleaning. all Degradation of the accommodation or its accessories will lead to rehabilitation The tenant. The inventory status at the end of the lease must be Strictly identical to that at the beginning of the lease; Any missing must be paid by the tenant.
  - (E) As security for these provisions of Article 5 (d), a security deposit of **€ 200** is required Of the tenant of a mobil-home the day of the handing-over of the keys and is returned to him on the day of end of Under deduction of the costs of restoration. This deposit shall not constitute Not a limit of liability.
- 6) The tenant must be insured in civil liability.
- (7) In the event of disputes, the Commercial Court of Lorient shall have sole jurisdiction.

## OFFICIAL RULES OF PROCEDURE

- 1) **CONDITIONS OF ADMISSION:** To be admitted to enter, settle, and stay On a campsite, it must have been authorized by the manager or his representative. It has an obligation to ensure the good behavior and order of the Camping and respect for the application of these rules of procedure. The fact of To stay on the campsite implies acceptance of the provisions of this And the commitment to comply.
- 2) **POLICY FORMALITIES:** Any person who must stay at least one night in the Campsite must first present to the manager or his representative And complete the formalities required by the police. The minors not Accompanied by their parents will not be admitted.
- 3) **INSTALLATION:** The tent or the caravan and the related equipment must be Installed at the location indicated in accordance with the instructions given by the Or its representative.
- 4) **HOST OFFICE:** The reception office will be provided with all the information The services of the campground, information on the possibilities of supply, Sports facilities, tourist attractions in the surrounding area and various May be useful.
- 5) **ROYALTIES:** The fees are paid at the reception desk. Their amount The object of a display at the entrance of the campground and at the reception desk. They are due Depending on the number of nights spent on the field. The users of the campground are They should inform the reception office of their departure from the day before the departure. The campers Intending to leave before the opening of the reception The payment of their royalties.
- 6) **NOISE AND SILENCE:** Campground users are urged to avoid All sounds and discussions that could hinder their neighbors. The sound equipment must Be adjusted accordingly. Door and lock closures must also be Discreet as possible. Dogs and other animals should never be left at liberty. They must not be left at the campground, even when locked in the absence of their Masters who are civilly liable. The silence must be total between 22H and 7H30.
- 7) **VISITORS:** After having been authorized by the Manager or his representative, the Visitors may be allowed to enter the campground under the responsibility of the Campers who receive them. The camper can receive one or more visitors at the reception. If these Visitors are admitted to enter the campground, the camper who receives them may Be required to pay a fee, to the extent that the visitor has access to the benefits And / or campground facilities. This charge shall be displayed The campground entrance and the reception desk. The cars of the visitors are Prohibited in the campground.

#### 8) **TRAFFIC AND PARKING OF VEHICLES:**

Camping, vehicles must drive at a speed limit of 10 km / h. Traffic is Prohibited between 22H and 7H30. The vehicle may only be used on vehicles Belonging to the campers staying there. Parking, strictly prohibited on Pitches usually occupied by camping shelters, shall not, moreover, Preventing the movement of new arrivals.

9) **HOLDING AND ASPECTS OF FACILITIES:** Everyone is obliged to refrain from any Which could affect the cleanliness, hygiene and appearance of the campground and Its facilities, in particular its sanitary facilities. It is forbidden to throw sewage on the ground or

In the gutters. "Caravaners" must empty their wastewater Facilities for this purpose. Household waste, waste of any kind, Papers, must be deposited in the garbage. Washing is strictly forbidden in Outside the bins provided for this purpose. The laundry is tolerated for up to 10 hours. Close to the shelters, provided that it is very discreet and does not bother the neighbors. It shall not

Never be made from trees. Plantations and floral decorations should be respected. It is forbidden for the camper to plant nails in trees, to cut Branches, planting. It is also not permitted to delineate the location Installation by personal means, or digging the ground. Any degradation Committed to the vegetation, fences, grounds or facilities of the campground Will be the responsibility of its author. The location that will have been used during the stay will

Be kept in the condition in which the camper found him when he entered the premises.

#### 10) **SAFETY**

**Fire:** Open fires (wood, coal, etc.) are strictly forbidden. Stoves Shall be kept in good working order and not be used in Hazardous conditions. In the event of a fire, notify the management directly. Fire extinguishers

Are usable in case of necessity. A first-aid kit is available at the snack.

**Theft:** Management is responsible for objects deposited in the office and has a general obligation

Monitoring of the campground. The camper keeps responsibility for his own And must notify the person in charge of the presence of any suspicious person. Though Guarding is ensured, the users of the campground are invited to take the Precautions for the safeguarding of their equipment.

11) **GAMES:** No violent or embarrassing games can be organized near facilities. Children should always be supervised by parents.

12) **DEAD GARAGE:** No unoccupied equipment may be left on the court, Only after approval of the management and only at the indicated location. A fee, of which The amount will be posted at the office, will be due for the "dead garage".

13) **DISPLAY:** These rules of procedure are posted at the entrance of the Camping and at the reception desk. It is given to the customer at his request.

**14) INFRINGEMENT OF THE RULES OF PROCEDURE:** In the event that a resident disrupts the stay of other users or fails to comply with the provisions of this Regulation The manager or his representative may, orally or in writing, Necessary, to demand the latter to cease the disturbances. In the case of a serious infringement or The rules of procedure and after formal notice by the manager of the May terminate the contract. In the event of a criminal offense, the May call upon the forces of order.

**15) MEDIATION OF CONSUMPTION:** In accordance with the provisions of article L612-1 of the Consumer Code, every client of the campsite has the right to use Free of charge to a consumer mediator with a view to amicable settlement of a dispute Which would oppose it to the operator of the land.
